4. Details of our assessment

This Compliance Assessment Report (CAR) accompanies the Operator Monitoring Assessment (OMA) audits for air and sewer that were completed on 04/07/23.

This Compliance Assessment Report (CAR) has been issued after reviewing the operator's auditing procedure (RUA-BM-PR-03) which was submitted to Natural resources Wales (NRW) on 02/08/23 and replaces CAR_NRW0042206 which was issued on 01/08/23.

Emissions to sewer are analysed by a UKAS accredited, third-party laboratory. The operator received an overall score of 76% for the OMA sewer audit. The following actions were given:

Sewer-OMA 2A- Action 1 – review the S1 chamber sampling arrangements and update your procedures accordingly.

Sewer-OMA2A-Action 2 – For the avoidance of doubt, the sample point shall be labelled.

Sewer-OMA-4D-Action3- Update audit procedure (RUA-BM-PR-03) to include specific sections relating to emissions monitoring (air and sewer).

Annual air emissions monitoring is carried out by a suitably qualified, MCERTS accredited third-party test house.

The operator received an overall score of 85% for the OMA air audit. The following actions were given:

Air-OMA1A- Action 1- Procedure RUA EN PR 17 Issue No 4 Monitoring of Emissions to Air should be updated to include requirement for SSP to be supplied, reviewed and signed off ahead of monitoring.

Air-OMA4D-Action2-Update audit procedure (RUA-BM-PR-03) to include specific sections relating to emissions monitoring (air and sewer).
