4. Details of our assessment

Dear Andrew Irving,

Thankyou for showing us around Treuddyn Poultry Unit on Friday 11th August 2023. Generally there was a high level of compliance with your permit, and your record-keeping is to a good standard.

There were two outstanding actions from the previous CAR form [Compliance Assessment Report CAR_NRW0040697 \(sharepoint.com\)](#) . I can confirm that these have been rectified as follows:

- The list of phone numbers in the Accident Management Plan has been updated with the correct contact number for NRW.
- All staff members at this facility are now fully up to date with training.

Non-Compliances

Just one non-compliance was identified during this visit:

The chemicals in the chemical store were kept secure in a locked room, and were stored with secondary containment. However the containers were poorly stacked two high, looked rather precarious and were in danger of toppling over outside of the bunded area.

Please extend the bunded area sufficiently that chemicals can be stored safely to avoid spill. This should be completed by the 22nd September, and photo evidence should be sent to your compliance officer Libby.Hughes@cyfoethnaturiolcymru.gov.uk
