## 4. Details of our assessment

### Introduction

This CAR form has been issued in response to Margam Green Energy Ltd. compliance submissions for Q2 2023.

The operator has reported that the plant was down for >80% of the quarter due to unplanned operational issues. This affected the collection of the air pollution control (APC) residue sample.

As outlined below, a sample was collected early in Q3 in an attempt to provide a representative sample for the limited operations during Q2. The operator has reported that this will not supersede the Q3 sample and a separate Q3 APC residue sample will be collected and reported to the permit schedule.

The Forms Air 1 Continuous and Performance 1 were submitted within the reporting period specified in permit condition 4.2.3 Reporting.

Form Residue 1 was submitted outside the reporting period specified in permit condition 4.2.3 Reporting, to allow for the collection of the APC residue sample.

### **Point Source Emissions to Air Parameters (Air 1 Form) as required by condition 4.2.3 (a)**

The Q2 (April to June 2023) submissions included results for all quarterly parameters required over this period. No exceedances of the permitted limits were reported during this period.

### **Residue Quality as required by condition 4.2.2 (c)**

The Q2 (April to June 2023) submissions included a representative sample for bottom ash taken within the quarter and, as outlined above, an APC residue sample collected on 5 July 2023.

### **Installation Performance (Performance 1 Form) as required by condition 4.2.2 (c)**

The Q2 (April to June 2023) submissions included results for all quarterly performance parameters required over this period.
