4. Details of our assessment

This Compliance Assessment Report follows a site inspection 07/09/23. The site manager was present.

Surface Water Drainage

It was verified that surface water runoff (rainwater) is now being discharged directly from the central collection chamber to the authorised discharge point (W1) without the use of the holding tanks or consideration of tidal conditions (as agreed).

This has been achieved by the installation of a length of flexible hose between the waste water plant inlet line and the normal discharge line.

As previously stated, it is important to note that the permitted emission limit values remain in force until permit surrender is achieved. Where practicable, spot samples should be taken of the discharge to allow assessment against emission limit values.

The operator continues to investigate the source of contamination (principally elevated COD) in the site's surface water drainage system as part of its requirement to demonstrate the installation meets the surrender tests. The investigation includes, but is not limited to, water quality sampling and testing and CCTV drainage surveys. In support of the surrender application, a report is due to be submitted to NRW's permitting team before the end of September 2023.

COD and ammonia analysis results for samples collected from the central collection chamber show that these parameters remain within their respective emission limit values.

During the inspection the central collection chamber contained water and some scum was noted present on the surface. A single one litre sample was collected from the chamber and was found to be clear and relatively odourless. The plant manager reported that the sump contained a mix of rainwater and town water that was used to flush part of the drainage system as part of the investigations referenced above. Whilst the sample may not be truly representative of site drainage it has been sent to NRW's laboratory for analysis.

Drum Store

It was verified that since the previous inspection the drum store has been cleared of all stored material.
