4. Details of our assessment

Following complaints received relating to noise from the Padeswood Site, NRW officers visited site on 09/08/2023.

15 complaints had been received between 01/06/2023 and 09/08/2023.

At the time of the inspection on 09/08/2023 the majority of the site was in a planned shutdown and the majority of processes were not operational with only Cement Mill 5 running. The Kiln, Raw Mill and Coal mill had been off for shutdown since 02/08/2023. Cement Mills 3 and 5 were operational at various times between 02/08/2023 and 09/08/2023.

The 2 most recent complaints had arisen during this period of shutdown.

NRW officers were in the locality on 08/08/2023 evening and were unable to perceive any noise from the cement works or link the reported noise with any site activities.

At the time of the inspection a Disab was operational at the Raw Mill and Coal Mill, the officers were able to perceive the sound generated by the Disab. This sound had not been perceived by the officers when they were offsite. The Operator confirmed and evidenced that Disabs were not operational during the night when the noise reports were received.

Officers noted that there was some localised equipment still operational such as hydraulic pumps and reiterated to the Operator that it was important that these items of equipment were considered as potential sources when investigating noise complaints.

Advice and Guidance: The Operator was advised to review the noise investigation report form to ensure it captures all potential sources of noise.

The Operators noise consultants were on site undertaking monitoring of specific equipment. At the time of the inspection they were monitoring the sound from the heat exchanger fans in various combinations.

The consultants were scheduled to conduct a night-time noise survey at several locations whilst the majority of the plant was not operational.

Two sound level meters were also deployed at the perimeter of the site during the shutdown to record noise levels for a two week period.

Action: The consultants reports should be forwarded to NRW when received.

Action: The Operator should review the recommendations and works identified from the reports, prioritise these and add them to the BAT action programme.
