4. Details of our assessment

A notification with Parts A & B completed was received by Natural Resources Wales (NRW) on Thursday 14th September 2023 providing details of a power cut local to the landfill. The power cut caused the failure of the compressors, gas engines and flare to operate. The operator stated that although suction was lost across the gas field there was no identified odour following an odour assessment carried out on the same morning. NRW has not received any odour reports from the public associated with this timeframe.

Bryn Posteg landfill has been subject to several localised and irregular power cuts in the past, the frequency of which, should be considered as an ongoing potential risk to adequate gas control. NRW acknowledges that power cuts arising on the grid are out of the operator's control. The operator however, is required by the permit to manage landfill gas by the permit. NRW requests that the operator investigate methods to maintain electricity supply for landfill gas control in the event of a mains power cut.

Action: Investigate and report on the potential for maintaining landfill gas control via alternate means of electricity supply to the landfill gas management infrastructure.
