4. Details of our assessment

On 23rd August 2023, Angharad Clark (Natural Resources Wales) attended the site with Calum Lewis (Environmental Health, Neath Port Talbot Local Authority). The visit was arranged due to reports of dust leaving the site.

Angharad Clark and Calum Lewis met with the site operator, Mark Davies. Mr Lewis explained that on a previous visit he had witnessed dust leaving the site and when he had

spoken to a worker at the site, he had attempted to turn the sprinkler system on. The worker was unable to turn on the system because the hose was damaged. This had occurred when the operator, Mr Davies, was away on holidays.

At the time of my visit on the 23rd August, there was no visible dust leaving the site. There was dust on the floor and Mr Davies immediately turned on the sprinkler system. Mr Davies stated that an additional new sprinkler was to be installed. Mr Davies also stated that he has access to a road sweeper and will bring it to the site to clean the roadways when necessary.

The lady in the office keeps a log of the days when the sprinklers are in use. Going forward, she will log the times of sprinkler use and when the road sweeper is used at the site.

Angharad Clark will inform Mr Davies as soon as possible when complaints are received. This will allow for proactive measures to be taken to reduce dust leaving the site.

ACTIONS:

- Install new additional sprinkler system.
- Record times and dates of sprinkler and road sweeper use.
- NRW will inform the site when complaints are received.
