**4. Details of our assessment**

On Thursday the 14<sup>th</sup> of September 2023 Natural Resources Wales officers attended the site.

The site was open with operatives on site performing their duties.

On arrival officers met with, Mark Williams, site manager and Technically Competent Manager (TCM). Mr Williams accompanied officers during the inspection.

The site was tidy and well-organised.

The site mainly accepts aluminium and only deals with companies, with no waste being accepted from the public.

The waste is stored in skips before being taken into the on-site furnace for melting, the product is then being placed in containers, stored separately, for onward transport.

There is no interceptor in place and the water drains through a soakaway.

You must ensure that all spills are cleared immediately and disposed of in the dedicated bins.

Metal filings need to be cleaned up whenever they are observed as they may cause blockage in the drainage system.
