4. Details of our assessment

At 10:30 on the 7th September 2023 a site inspection was undertaken by NRW officers Phil Harper and Victoria Griffin (Senior Industry & Waste Regulation) and Cheryl Griffiths (Environment Officer).

The primary focus of the visit was the operation of scrubber systems and to gain an understanding of the function of the effluent treatment plant.

Scrubbers

At the time of the inspection water was still being used as the scrubber liquor for on site scrubbers. As detailed in the previous compliance assessment report CAR_NRW0042010, documentation which was provided by the operator during the permit application process shows that scrubbers will be operated with scrubber aqueous scrubber liquors which are enhanced with acid or basic additives.

In addition to the advice provided by the previous compliance assessment report, a formal warning letter was issued to the operator on the 25th July 2023 detailing that NRW believed that an offence was being committed by failing to use the appropriate liquors in scrubbers.

A category 3 permit has been applied breach contrary to permit condition 2.3.1(a) ((IR2C) Operating Techniques).

Action 1: As agreed during the site meeting, submit plan to NRW detailing the possible next steps to address the emission limits breaches at the scrubbers and the reintroduction of scrubber liquors by the **6th October 2023**.

CATOX

The inlet temperature for the CATOX was observed during the inspection. The inlet temperature was set as per the manufacturers guidelines.

Integrity of Concrete

Areas where concrete had cracked were observed during the site visit, especially behind the chemical manufacturing area and towards the lagoon.

Action 2: Put forward a timeline for the inspection and repair of these areas by the **6th October 2023**.

No further issues were noted during the site inspection.
