4. Details of our assessment

An unannounced, routine inspection was carried out by David Ellar (NRW). Met with company Director Hefin Roberts, who accompanied me around site. All areas of site inspected. Weather conditions overcast and damp.

No breaches/issues observed at time of inspection.

NRW have been unable to fully inspect the site during the last few visits due to no waste activity being undertaken and the gates being locked. On this occasion Hefin Roberts was on site. Mr Roberts explained that he had vastly scaled down the operation over the last few years and he was only running one skip lorry and only 'doing a few skips a week'. Only household skips being sorted at site and Mr Roberts is currently the only employee.

The AD plant was not in operation and had not been for several years. Mr Roberts was exploring options with a view to possibly sell the package plant. No AD wastes were on site. Mr Roberts will keep NRW updated with any changes to the waste operation.

Only a few small stockpiles of waste were present on site and they were inside the sorting shed. The waste observed was suitable and consistent with the permit.
