4. Details of our assessment

A routine, unannounced inspection was carried out at Plot 10 TBS who operate under a Standard Rules Permit (EPR/VP3598FA) SR2008No3 a Household, Commercial and Industrial Waste Transfer Station with Treatment. There are no exemptions registered for the site. Weather was dry and hot.

Present on site during the inspection was Amy Thomas (TBS) and Stephen Thomas (TBS)

At the time of the visit, waste appeared to be well sorted and separated.

B1 Engineering for prevention and control of emissions Category 3 breach of condition 2.3.1

The roof was still in need of repair following the fire incident that took place in August 2022. The internal walls appeared to be damaged and also needs to be repaired.

Action: Please provide dates, by 6 October 2023, when you expect to have repaired the roof and internal walls.

C2. Management Systems and Operational Procedures

The Environmental Management System (EMS) need to be reviewed and updated.

Action: Please provide NRW with an updated EMS by 18 March 2023.

B1 Engineering for the prevention and control of emissions

Please note that the standard rules permit does not authorise a discharge to groundwater or directly to surface water, from areas used for the storage or treatment of waste. The permit does not authorise mechanical treatment of waste.
