Celsa provided a Schedule 5 Notification dated 13/5/2019 in respect of a fugitive dust release that occurred on 18/4/2019 at 13:49h. The release was from the Mineral Site where slag screening was in progress. The work was being carried out by contractors.

NRW first became aware of the incident following a complaint that was received on 18/04/2019 at 16:04h.

Celsa were contacted following the report to NRW and investigations were instigated.

NRW visited the area on 24/4/2019. There was evidence of significant fugitive dust deposition on Tidefields Road, the adjacent verge and Mineral Site boundary fence. Photographic evidence was recorded. In addition it was noted that there was no wind sock present. This serves to provide a valuable indication of wind direction and strength to inform site operations.

Celsa have identified a number of measures to prevent recurrence of the incident, these are accepted as appropriate.
