### 4. Details of our assessment

This CAR form is in response to WIRS ref: 2301367 / SAP ref: 316457788

As a result of a blockage formed between the flow control and screen chamber as described by Dwr Cymru in OPNOTS related to this incident, the asset has discharged

sewage in dry weather in contravention of the following condition:

2.3.1 For the discharge(s) specified in table S3.3:

(a) The discharge shall only occur when and only for as long as the flow passed forward is equal to or greater than the overflow setting indicated due to rainfall and/or snow melt and shall only consist of flows in excess of that figure.

It is noted remedial action was taken at the time of this incident and the blockage removed. Dwr Cymru have also undertaken a CCTV survey which identified siltation which has been removed. Dwr Cymru have committed to undertake a yearly maintenance programme and a monthly visual inspection.

The incident has been classified as Low level/Cat 3 due to the ammonia levels within the discharge and the visual impact.

A warning letter will be issued as an enforcement response for this incident.
