4. Details of our assessment

6 Monthly Monitoring – A5 Carbon Filter.

Biogen submitted to NRW on the 13.9.2023 emission monitoring results for A5, carbon filter abatement. Biogen are required to submit monitoring every 6 months for Ammonia and Hydrogen Sulphide. All monitoring results are compliant with the permit.

The result for ammonia was 0.68 mg/m³ and is within the permitted limit of 20mg/m³.

Hydrogen Sulphide was recorded to be 1.32 mg/m³. There is no emission limit for Hydrogen Sulphide.

Odour concentration was also measured at the inlet and outlet of the carbon filter and showed a highly efficient reduction of 99%

Biogen replaced the carbon filter on the 31st July 2023.
