4. Details of our assessment

This Compliance Assessment Report follows a prearranged familiarisation visit and routine inspection of the Installation by Natural Resources Wales (NRW) regulating officers Carter Shone and Rebecca Harwood on 13 September 2023.

A brief introductory meeting was held with the Technical Manager, Waste Transfer Station Manager, HS&E Manager and the site chemist before NRW officers were provided a tour of the full facility, including the permitted area (Installation Boundary edged dark blue, Schedule 7 – Site Plan) which covers a small area to the north of the site.

The site was clean and tidy with all waste clearly labelled and separated into marked bays with dividing concrete sills. The permitted area has separate drainage for containment and there was no evidence of any spills. The Operator stated that all bulking up of loads for transfer off site took place within the permitted area.

The Operator confirmed that the solvent bulking tanks were not in use. Officers suggested that if the storage tanks remained unused the Operator may wish to consider removing this operation from the permit in any future variation.

Outside of the permitted area the operator had product stored in both repurposed ETP tanks and IBCs. The Operator stated that these IBCs did not contain waste. The IBCs were stored in a separately bunded area and the former ETP area also has separate drainage for containment.
