4. Details of our assessment**7 x MINOR TEMPERATURE BREACHES BETWEEN 6/09/23 AND 12/09/23**

A schedule 5 notification has shown seven breaches of permit limit for effluent discharge from your facility into the Afon Erch. The breaches in question on this occasion were for Temperature. These breaches were sampled between the 06th September 2023 and 12th September 2023

Permit condition 3.1 states:

3.1.1 There shall be no point source emissions to water, air or land except from the sources and emission points listed in schedule 3 tables S3.1, S3.2 and S3.3.

3.1.2 The limits given in schedule 3 shall not be exceeded.

The limit for temperature is 25 Celsius and the values reported exceeded this limit.

The result on this occasion was deemed to be due to the very high ambient temperatures affecting base operating temperatures. Therefore, due to multiple relatively minor breaches a single consolidated score of CCS 3 has been attributed.

ACTION: Management should assess the options for temperature control during warm weather periods, as adding additional heat to the river in such conditions is detrimental to the ecology of the Afon Erch. This assessment should be submitted to NRW by the 31st October 2023
