4. Details of our assessment

This was a pre-arranged inspection, primarily as a familiarisation visit of the facility to the new regulating officer for the site, Kathryn Bradshaw and accompanied by Paul Challender the previous regulating officer.

The Flint site Energy and Environmental Leader was the host for the visit accompanied by the Operations Manager for Coleshill Mill and the Site Operations Manager. An overview of the company and site operations were provided. We were given a detailed guided tour of the Coleshill Mill facility. This included the waste reception area, site drainage, the air and water discharge points and the effluent treatment plant (ETP).

The actions from the previous CAR forms (NRW0042090 & NRW0041958) were discussed and evidence of the completion of the actions were submitted by the deadline dates stipulated in the CAR forms. The area of the ETP where the complete replacement of two underground pipes was viewed and this work is still ongoing.

The other outstanding action was to review the tissue machine shutdown and the impacts to the ETP, experts have visited the ETP but have yet to provide the report. This will be forwarded once received.
