Thank you for your letter 21 September outlining Natural Resources Wales' concerns with regard to the appellant's final comments submission.

PEDW has considered NRW's points of concern and also the "rebuttal" submission from the appellant of today's date (also copied to NRW). I confirm that PEDW will accept the appellant's final comments on the basis that they are considered to be a response to NRW's Statement of Case and, whilst it would have been desirable to have had much of this information at SoC stage, the appellant has explained why this was not possible.

We appreciate that NRW may not agree with this assessment, however, given the concerns raised, we are now providing NRW with a further final opportunity to comment.

I would therefore be grateful for NRW's response to the matters raised in the appellant's final comments submission (and no other matters) within 21 days (ie. by 17 October). Any response received will be copied to the appellant for information only and no further submissions will be accepted.
