4. Details of our assessment

This CAR has been produced to acknowledge receipt of and approval of Knauf Insulation Limited's notification of electrostatic precipitator shut down and operation of the site's by-pass stack.

The shut down and by-pass stack operation will take place between 2nd October 2023 14:00 to 4th October 2023 14:00 for the purpose of undertaking maintenance.

Measures taken, or intended to be taken, to rectify, limit or prevent any pollution of the environment which may be caused by the emission are: glass pull rate and furnace output to be reduced.

As per condition 4.3.5, where the operator proposes to make a change in the nature or functioning, or an extension of the activities, which may have consequences for the environment and the change is not otherwise the subject of an application for approval under the Regulations or this permit: Natural Resources Wales shall be notified at least 14 days before making the change.

With the referenced notification being made at 15:30 on 19th September, Natural Resources Wales have deemed this notification falls within the 14 day notification period.

The above represents compliance with permit conditions 4.3.5, 3.1.1 and 3.1.2.
