2 x CHLORIDE PERMIT BREACHES

08/09/23 and 13/09/23

E3 - Emissions - Surface water C3 3.1.1, 3.1.2

Schedule 5 notifications have shown 2 breaches of permit limit for effluent discharge from your facility into the Afon Erch. The breaches in question on this occasion are for Chloride. The breaches were sampled on the 08/09/2023 and 13/09/2023

Permit condition 3.1 states:

3.1.1 There shall be no point source emissions to water, air or land except from the sources and emission points listed in schedule 3 tables S3.1, S3.2 and S3.3.

3.1.2 The limits given in schedule 3 shall not be exceeded.

The limit for chloride is 520mg/l and the values reported were 561mg/l and 557mg/l respectively.

These chloride breaches are above the permitted limit. It is therefore, in the context of this discharge, considered a minor breach on each occasion. The breaches have been consolidated into a single CCS3 score.

ACTION: Please investigate and improve process to ensure levels of chloride remain compliant.
