Site visited due to concerns raised by a member of the public regarding the spill frequency for this site.

No problems were identified during the visit in terms of the conditions of the storm tanks etc. However it is noted from the Rivers Trust website that the site spilt 100 times in 2022 for a total of 640 hours.

Can you please confirm the accuracy of this spill data and whether any work is planned to reduce spill frequency.
