4. Details of our assessment

Acceptance of non-waste crops

Biogen informed NRW on the 25.07.2023 of their intention to accept non-waste crops for anaerobic digestion.

The non-waste crops will supplement the sites continued acceptance of food waste and other types of waste listed in their environmental permit.

NRW accepts the change in feedstock as the non-waste crops are already listed in the environmental permit as EWC codes 02 01 03, plant-tissue waste and 02 03 04, materials unsuitable for consumption or processing. The non-waste crops have no negative environmental impact to the process and no permit variation is needed to accept non-waste crops that fall under EWC code, 02 01 03 and 02 01 03.

The non-waste crops are stored offsite and will be brought to the site when needed. Crops will be tipped into the reception building following the same measures and controls as the food waste crops. All incoming non-waste crops will be recorded in the sites environmental management system. Biogen has extensive experience of non-waste crops and feedstocks from their agri-AD sites.
