An unannounced visit was made by David Ellar and Hugh Martin (NRW). During the visit NRW officers were accompanied around the site by site foreman Phil Harris (Enviroventure).

The weather was grey and overcast and it had been raining.

No non-compliances or permit breaches were recorded under this permit.

At the time of the inspection, activities relating to this permit were not being undertaken. There was no ELV waste in the building relating to vehicle storage, depollution & dismantling. It is noted that it is the intention of Enviroventure to keep this Environmental Permit active.

The building was being used to store and bale cardboard but this was being undertaken under Enviroventures other permit (JB3531AB). The permits share the same boundaries.
