Quarter 1 & 2 2023 Waste Returns

IR4B - Reporting

Waste returns for quarters 1 and 2 of 2023 have been received for the site as required by permit condition 4.2.2.

The waste returns were reviewed and there were no issues identified.

Annual emissions monitoring

Following the submission of your annual emissions monitoring on 25th April 2023 a CAR form was raised (NRW0041823) that reviewed the submitted data. An action was identified on this CAR form:

1) Carry out an investigation into the fuel efficiency of the sites MCP, including whether improvements to the fuel efficiency can be made and provide an update to NRW by the 16th June 2023. This has not been received by NRW to date.

Action - provide an update on the above to NRW by 27th October 2023.

IR1A - General Management.

As per permit condition 1.1.1;

The operator shall manage and operate the activities: (a) in accordance with a written management system that identifies and minimises risks of pollution, including those arising from operations, maintenance, accidents, incidents, nonconformances closure and those drawn to the attention of the operator as a result of complaints; and (b) using sufficient competent persons and resources.

and 1.1.2;

Records demonstrating compliance with condition 1.1.1 shall be maintained.

This was noted on the first site inspection on 23/05/2022 (CAR - NRW0039950). Officers were shown a draft copy of the site operating procedures but it was not in a form that could be sent and reviewed by NRW.

An action was given to provide a copy of the environmental management system (EMS) to

NRW by 31st August 2022. NRW have not received a copy of the EMS to review and retain within the site records.

Action - send a copy of the site EMS by 27th October 2023
