4. Details of our assessment

This compliance report details the site inspection conducted by Natural Resources Wales (NRW) Officers on 26/09/2023 at: East Bank Road, Felnex Industrial Estate, Newport, NP19 4XB- Permit number **EPR- AB3197TY**.

Waste Regulation Officer Jak ROSE arrived at site at 11:05 and met with Operator Noel FITZPATRICK and Site Manager/Technically Competent Manager Anna FITZPATRICK. The last inspection was completed on 25/08/2022. It was requested that a walk around the entire site was undertaken. The weather conditions were fine and dry during the time of inspection.

No breaches/issues observed at time of inspection.

Site observations

Officer ROSE entered via the main entrance gates on East Bank Road. Access to the site is via a coded lock which the operator only has access to.

No plant was in operation at the time of inspection, the crushing of waste material takes place on an ad-hoc basis. Each time this is undertaken it is documented in a site log.

No issues apparent with drainage/infrastructure on site at time of inspection. There was some standing water on site due to the recent heavy rain. This was not of concern and the drainage system appeared to be functioning correctly. Some of the surface water is re-used on site to dampen down wastes when they are being processed.

The incoming wastes received for processing will be from Fitzpatrick's own sites therefore pre-acceptance checks are of a high standard. Waste transfer notes from the past month were checked and these are being completed correctly.

Incoming wastes are brought back to site for processing and then re-used as various grades of recycled sub-base and dust for re-use on projects.

The operator raised concerns of litter being blown in from the neighbouring site as shown in the photos below. The site next door GD Environmental appear to have some gaps in their boundary fencing which is causing waste to bypass via the netting.

Environmental Management System (EMS)

Officer ROSE reviewed the EMS documents that are kept on site. These appear to be accurate and updated on an annual basis.

All the wastes accepted at the site follow the recycling process chart outlined within the EMS. These comply with the wastes that can be treated by sorting, separation, screening, crushing, and blending as specified within the permit.

Technically Competent Manager (TCM)

Anna's proof of continuing competency is up to date. The certificate expires 11 February 2024.

These are up to date and reflect correct waste codes within the permit.
