On Tuesday 12th September 2023 Officer Chris Burge attended at Volehurst Limited, Old Esso Depot, Usk Way, Newport, Gwent, NP20 2BU to complete a routine unplanned compliance inspection of the permit EPR-KP3595FB.

Officer Burge met with Director Mike WEBB on site.

Following arrival at site, staff hand picks the waste and sort into different waste streams ready for the removal to other permitted facilities

Photo 1 shows the staff sorting the waste



There is a stockpile of Construction and demolition waste at the site, Mike WEBB explained this is stockpiled until he has a large load to fill his lorry and then removed to Newport Landfill. The material is stored for no longer than 6 months

The site is well organised and has a large concrete area for sorting and storing of the waste.

The site TCM holds a current Wamitab certificate .
