4. Details of our assessment

Thank you for showing my colleague Ruth Skillen and I around Braich yr Alarch Free Range Poultry Unit on 11th September 2023.

The unit only started operating in December 2022, and this was the first visit by NRW staff to the unit.

We checked through the paperwork, and identified a small number of minor issues, all of which you have already remedied:

- The Accident Management Plan needed populating with phone numbers and contact details. This had already been completed by the end of our visit.
- You have provided a Policy Review Plan detailing how regularly you intend to review and update the various plans and policies which are included in your Accident Management Plan.
- You have provided an Inspection Plan detailing the frequency of inspection and maintenance of the different areas and systems present at the facility

We also had a walk around the facility, and no issues were identified. I am able to confirm that you are currently compliant with your permit.

I understand that the poultry litter is removed from your facility twice a week by several local farmers, and that several others have expressed an interest in acquiring some in the future. This is just a reminder that you must ensure that you maintain good records as to where (and when) your poultry litter is going, as under the Control of Agricultural Pollution Regulations 2021 all recipients should be recording any imports of nutrients to their farms, and recording all spreading to land within their nutrient management plans. You should be aware that from August 2024 onwards, in the 6-month period between 1 October and 1 April farmers receiving your poultry litter should be storing the manure in buildings, yards or hard-standing, and should not be spreading it to land.
