4. Details of our assessment

This Compliance Assessment Report follows a review of routine quarterly emissions monitoring returns during the period 1st April - 30th June 2023.

All reports received on time.

a) Emissions to Air

Emission points A1 - A4 all emissions compliant with the permitted limits throughout the period. .

Emission points A10A - A10E, annual extractive NOx and CO monitoring completed on all 5 auxiliary boilers 27 -28 June 2022. No emission limit values apply, emissions found to be typical of those recorded during previous monitoring rounds.

b) Emissions to Water

Emission points W1, W2 & W3 - all parameters within permitted limits.

c) Gas Treatment Plant

A NIL return was submitted.

On 28/07/23 Uniper advised NRW that -

'The Gas Treatment Plant ceased operation upon the 30th June 2023 and as a result all treatment / processing of natural gas from the ENI owned Liverpool Bay fields by the Connah's Quay installation has ended permanently. The Gas Treatment Plant is no longer in operation and consequently Uniper hold no current intention to return the plant to service at any point in the future.

There was no regeneration of the Gas Treatment Plant molecular sieves in 2023, and so therefore we are unable to complete any monitoring on the Gas Re-Gen Heater (emission point A12) in 2023.

With the retirement of the Gas Treatment Plant, Uniper will longer be in a position to complete monitoring returns upon the Gas Treatment Plant within these quarterly Environmental Permit submissions'.
