Natural Resources Wales officer Shaun Rees met with Mr Jones to carry out a routine Audit for the site on the 2nd October 2023. Thank you for your time during the visit.

Although no non compliances were identified, please see below advisories to improve the operation of the site.

Emergency Plan

An emergency plan was available on the site which included the site plan and the list of raw materials, but i would advise that a copy of these be made available at the entrance gates by the 31st October 2023 and evidence provided.

Export of manure

Export of manure records in place, but full address of receiving farm required, Please ensure this is changed by the 31st October 2023 and evidence provided.

Record Keeping

Although all documents were available during the audit, i would advise that the filling system be improved slightly to accommodate future NRW audits by the 31st October 2023 and evidence provided.
