This OMA focused on the monitoring of emissions to air (Periodic and CEMs) from Stack Emission Release Points A1 and A2 (Line1 and Line 2) at Cardiff Energy Recovery Facility operated by Viridor Waste Management Ltd.

Viridor (Operator) and the Monitoring Test Consultants employed (SOCOTEC) have demonstrated and provided comprehensive evidence that quality control for periodic and continuous monitoring is well managed, providing extremely reliable monitoring data.

Competency of periodic and continuous monitoring, staff, and quality assurance were all high. This is well documented throughout this audit that resulted in a very high score of 100%.

There are no recommendations noted during this audit, that Viridor should consider for future management of monitoring and periodic testing.
