Natural Resources Wales (NRW) received a Schedule 6 Notification from Kennametal on 3rd June 2019. The emission limit value (ELV) for particulate emissions from A6 had been exceeded during monitoring carried out on 9th April 2019. The measured value was 253.4mg/m³; the ELV is 25mg/m³.

This is an on-going problem which Kennametal are working to solve. It may be necessary to vary the permit ELV once results from full cycle monitoring of the oven have been assessed.
