4. Details of our assessment

Industry and Waste Regulation Officer Magda Leonowicz and the Hazardous Waste Officer Craig Coleman visited the site to conduct a site inspection. The officers met with Brett James - Safety, Health, Environment and Quality (SHEQ) Manager, who accompanied us during the inspection.

The purpose of the visit was to make introductions and learn about the site and its processes. The weather was warm and dry at the time of the visit. The details of the visit are as follows.

Currently the business mainly accepts and temporarily stores a high-quality waste cardboard, waste plastic and small quantities of filter cake material. All the waste is temporarily stored and baled or bulked up for onward transfer. There is no prolonged storage as the turnover rate of the waste is high. The building benefits from the impermeable surface with a sealed drainage system. All the waste storage and treatment took place within the building at the time of the visit.





Technically Competent Manager (TCM)

We do not have up to date record of the TCM in our database. Please provide an evidence of qualification of the current TCM within 10 working days.

The waste returns were last provided on 31 July 2023. I have noted that some of the EWC codes included in the waste returns form are not part of your permit, but they are part of the registered exemptions.
