4. Details of our assessment

This report details the site visit made on the 21 September 2023 to TXO Systems Limited, permit reference number EPR AB 3297TQ. Officer Carla CURTIS attended site Unit 3 to 6 Severn Cross Distribution Park, Newhouse Farm Industrial Estate, Chepstow, NP16 6UP for a routine site inspection at around 13:50, the weather was warm and sunny. Officer had a site tour by Julia Evans, Operations Director.

GENERAL OBSERVATIONS – TXO Systems have in place a comprehensive management system and are operating to ISO 14001 Certified EMS and ISO 9001 Certified QMS. All WEEE instrumentation / end of life equipment and materials stored and dismantled inside the main operational building. The general housekeeping of the site was kept to a good standard, yard drains to mains foul sewer. All infrastructure relevant to process is sound and robust. No issues noted during visit: TXO Systems operate to very high standard in line with the EMS and QMS.

TECHNICAL COMPETENCY – Julia Evans is the TCM for the site, copy of certificate received, expires 26 June 2025.

WASTE RETURN SUBMISSIONS - The maximum waste quantity that can be accepted by the site is 75,000 tonnes per year. Responsibility for waste returns lies with Julia Evans. Waste returns information appears to be up to date and within permit limits. The waste return for Q2 2023 was submitted on 31/07/23, Waste accepted: zero tonnes. 435.3 tonnes removed from the site as waste, coded as 200140, 160601, 160215, 150102 & 160215. Please continue to submit quarterly waste returns within one month of the end of each quarter, in line with your permit.
