4. Details of our assessment

This report details the site visit made on the 26 September 2023 to Recresco Limited, permit reference number EPR-DB3797TC. Officer Carla CURTIS attended site at 11:15.

The purpose of the visit was following a number of reports of Burning smell / fuel type odour, within the Springvale area, which was alleged to be coming from Recresco Limited (WIRS Numbers 2307009, 2307035, 2307103 & 2307104)

Kevin EDWARDS (Depot Manager) and Sacha EVANS (Administrative Manager) accompanied officer CURTIS around the site. Weather conditions were mild and overcast at the time of inspection. Kevin EDWARDS advised that there has not been any burning on site and following a thorough inspection of the yard and boundary, no signs of burning were observed.

The following observations were made during the site visit.

All processing of glass is undertaken inside the building before being sorted and stockpiled by colour. Maximum storage before processing is 500 tonnes, The product (not waste) is stored outside.

Infrastructure and drainage of the site was inspected, the impermeable surface was in good condition throughout the site. The drainage system is to foul sewer, they have recently had work done on site to improve the drainage.

Technical competency - The Technically Competent Manager (TCM) for the site is John MADDUX, WAMITAB certificate has been provided and expires 13 April 2024.

Waste Returns submissions - the latest waste return for Q2 2023 was submitted on 20/07/23. Waste codes accepted: 150107 & 191205, totalling 36163.9 tonnes. 5116.36 tonnes were removed from the site as waste, coded as 191212, 191205. 191203 & 191202 and sent to landfill sites and glass recycling & Metal Recovery. The permit stipulates a maximum tonnage of waste to be accepted at the site per year at 220,000 tonnes. Please continue to submit quarterly waste returns within one month of the end of each quarter, in line with your permit.

Permit compliance and breaches - No permit non-compliances were identified on this visit and thus no breaches have been scored.
