4. Details of our assessment

The purpose of this Compliance Assessment Report (CAR) is an assessment of the Q2 2023 monitoring results and compliance notifications.

The quarterly monitoring data specified in condition 3.6.1 Reporting was received from the operator.

Schedule 6 Notifications - Groundwater - Q2 April to June 2023

A Schedule 6 Notification submitted to NRW on 25 April 2023 gives the measured mecoprop result at monitoring point BH3/9 on 11 April 2023 as 0.129 µg/l.

BH3/9 does not have an emission limit for mecoprop, however the detection of mecoprop in this upgradient well does provide useful context for consideration in the ongoing monitoring exercise to determine the source of downgradient exceedances.

Schedule 6 Notifications - Surface Waters - Q2 April to June 2023

A Schedule 6 Notification submitted to NRW on 25 April 2023 gives the measured mecoprop result at monitoring point SW205 on 11 April 2023 as 0.103 µg/l. This is an exceedance of the permitted emission limit of 0.055 µg/l and represents a breach of condition 3.1.2 and non-compliance with the environmental permit.

Compliance: The above result is in exceedance of the emission limits set in the permit for SW205. A non-compliance score of C3 against criteria IR3A has been allocated to this breach over the Q2 April to June reporting period.

As requested by an action in CAR_NRW0040951, the Operator has provided review of mecoprop trends across site monitoring network.

Action: Operator to implement recommendations of mecoprop trend review and submit report to NRW:

- Monitoring of Cell 1/2 Sump trends to continue, including review of groundwater levels and rainfall data.
- Consultation with surrounding landowners to determine field spraying routines and potential sources of mecoprop.

Since the issue of the most recent permit variation (CP3735PB/V004) in 2009, the list of hazardous substances has been updated, and mecoprop removed from the list. The operator may wish to initiate a variation of the permit to revise the monitoring tables to reflect this change.
