## 4. Details of our assessment

This Compliance Assessment Report follows a review of Quarter 2 2023 (April - June 2023) CEMS data, biannual air emissions monitoring and residues monitoring.

### 1. Q2 CEMS monitoring

Monitoring data was received monthly from the Operator as previously agreed.

Condition 3.2.1 requires that emissions to air will not exceed levels set out in Table S3.1. Having reviewed the data submitted, the following ELV breaches have been identified for Q2.

Particulate Matter - exceedances of the ½ hour average ELV of 30mg/Nm<sup>3</sup> were recorded on the 19 May, 26 May, 27 May and 30 May 2023. It is noted that those on the 26 May and 30 May have been linked to a calibration issue that has now been resolved **The other**

**exceedances have been scored a category 3 breach of Condition 3.2.1.**

Particulate Matter – an exceedance of the daily average of 10mg/Nm<sup>3</sup> was recorded on 19 May 2023. **This exceedance has been scored a category 3 breach of Condition 3.2.1.**

Hydrogen Chloride - exceedances of the ½ hour average ELV of 60mg/Nm<sup>3</sup> were recorded on the 26 April, 2 May, 31 May, 16 June and 21 June 2023. The exceedance from 16 June was a result of an issue with the lime dosing screw and therefore constitutes abnormal operations. The exceedances from the 21 June were after shut down had been instigated and the kiln was being maintained at approximately 1000°C. The Operator is undertaking further investigations into the reasons behind this. **The other exceedances have been scored a category 3 breach of Condition 3.2.1.**

Hydrogen Chloride - exceedances of the daily average of 10mg/Nm<sup>3</sup> were also recorded on 2 May and 21 June 2023. **The exceedance from 2 May has been scored a category 3 breach of Condition 3.2.1.**

Carbon monoxide - exceedances of the 10 min average of 150mg/Nm<sup>3</sup> were recorded on 19 May, 1 June and 19 June 2023. **These exceedances have been scored a category 3 breach of Condition 3.2.1.** There were no exceedances of the daily average ELV of 50mg/Nm<sup>3</sup>.

VOC - exceedances of the ½ hour average ELV of 20mg/Nm<sup>3</sup> were recorded on the 8 April, 19 May and 1 June 2023. The Operator has stated that these exceedances all occurred during a period of start up. There were no exceedances of the daily average ELV of 10mg/Nm<sup>3</sup>.

Exceedances across the quarter have been consolidated per parameter.

There were no breaches of sulphur dioxide or NOx above the ELVs.

Notifications were received for the above exceedances in accordance with Condition 4.3.2. These cover the investigations relating to the exceedances and no further action is required at this time. NRW may investigate further some of the causes if exceedances continue.

## **2. Biannual Air Emissions Monitoring**

Condition 3.6.1(a) requires that biannual air emissions are undertaken in accordance with Table S3.1. Condition 3.1.2 states that the limits in Schedule 3 shall not be exceed.

Bi- annual monitoring from emission point A1 was undertaken during March 2023.

There was an elevated reading relating to heavy metals during the monitoring, however, once the level of uncertainty has been taken into account this result is complaint.

There were no exceedances of the emission limits.

**3. Bottom Ash & APC residues**

Bottom Ash and APC residues sampling was undertaken in accordance with Conditions 3.6.1(c) and Table S3.5. Ash composition remained below the 3% TOC limit.

Copper results within the bottom ash remain elevated and similar to Q4 2022 and Q1 2023 results.

Dioxin analysis in the APC Residues remains high.
