4. Details of our assessment

Review of emissions monitoring April - June 2023

Emissions monitoring data covering the period 1st April to 30th June 2023 was received on 28th July 2023 in accordance with permit condition 4.2.3.

Emissions to Water

No exceedances have been identified within the monitoring return for emission point W1.

Emissions to Air

Continuous Monitoring (A5, A8, A9, A15)

All continuous emissions monitoring was provided as required by the permit and shown to be within the permitted limits during this period.

Periodic monitoring (A15, A8)

Particulate monitoring was undertaken at Cement Mill 5 (emission point A15) on 16 May 2023. No issues noted.

Following the elevated mercury reading at the Kiln 4 main stack (emission point A8), as detailed in CAR_NRW0041879, the Operator undertook a retest and a result of 0.035 mg/Nm³ was obtained, below the permitted ELV.

The Kiln by-pass dust 6 monthly analysis was also submitted.

ARM and WDF Reporting

Alternative raw material / waste derived fuel usage for April – June 2023 has been

reported.

Summary of Schedule 5 Notifications Received

A Schedule 5 notification was submitted to NRW following a dust release from Cement Mill 5 on 8th June 2023. The release was as a result of the mill fan tripping. The investigation report states that a maximum dust reading of 72mg/m³ was recorded on the FN45 stack process monitoring 10 minutes after the fan had tripped, the ELV for periodic monitoring is 10mg/m³. The Operator noted that as the fan was off there was a very low flow. No dust complaints were received as a result of the release.

The investigation report states that there was a delay restarting the fan as an error message was not clearing. Subsequently it was identified *“that the stack damper will need to be at 100% to enable closing of the recirculation damper”*. The Operator has stated that further training is to be undertaken to ensure shift analysts understand the procedure to prevent a further occurrence and delay in restarting the fan.

A lack of training of key personnel represents a management system failure. **A category 3 score, under subheading IR1A General Management, has been applied against permit condition 1.1.1.**

As corrective actions have been put in place and further training is to be rolled out to shift analysts no further action is required. NRW may review training records as part of a future compliance visit.
