4. Details of our assessment

Form W1, Emissions to the Estuary for 1st July to 30th September 2023, was received on 5th October 2023.

All parameters, except formaldehyde, were within their respective emission limit values (ELV). The report is accepted.

The ELV for formaldehyde was exceeded in the composite sample for the week ending 17th August 2023. The measured value was 13.5mg/L; the ELV is 10mg/L. A Schedule 5 Notification, Part A, has been submitted for a previous breach of the ELV for formaldehyde emissions to water. This exceedance is covered by that notification as the possible causes are the same and the investigation is on-going, (see CAR_NRW0042205). Results should be available in due course.

Natural Resources Wales will decide what enforcement action to take once the Part B Notification has been received and these results, and any remedial actions, have been discussed with Solutia.
