## 4. Details of our assessment

This was a pre-arranged inspection, primarily as a familiarisation visit of the facility to the new regulating officer for the site, Kathryn Bradshaw and accompanied by Rebecca Harwood the previous regulating officer.

We were met on site by the General Manager, Assistant Operations Managers and Environment Advisor. We were provided with an overview of the site operations and the processes involved. We were given a detailed site tour of both the MBT and IVC facilities where we viewed the different steps in the process, including the biofilters and emission point A1. The site currently tankers off the leachate from the bio-drying tunnels.

The site was operational at the time of our visit although waste levels were lower than normal due to ongoing industrial action at Wrexham County Borough Council. A fully automated fire detection and deluge suppression system has been installed and a video demonstration of the system was shown during the visit as well as the water and pump storage areas.

### Action

Please forward a copy of your updated Fire Prevention and Mitigation Plan (FPMP) to NRW.

Discussions were held about maintenance of the current fire water tank which requires emptying. NRW will communicate a response to this query separately.  
No issues were identified on the MBT and IVC facilities during the inspection.
