Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

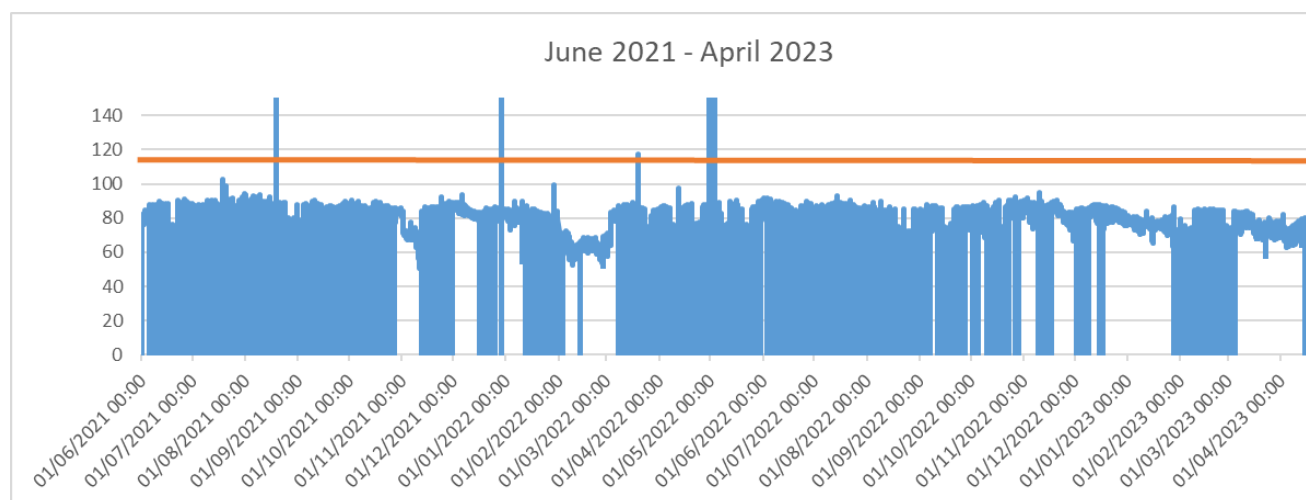
You are non-compliant with your permit.

We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

A data audit of the Pensarn SPS has been carried out by NRW. A permit breach of condition 4 has occurred where the pass forward flow (PFF) has been less than 115 litres per (L/s) second whilst storm discharges have taken place.

Below is a graph illustrating PFF data from June 2021 to April 2023



Pass forward flow (PFF) for this asset is 115l/s before the asset is permitted to discharge. during this period PFF never gets above 90l/s as such our calculations are based on 90l/s for PFF, this is at least 25l/s which was not being passed forward. The orange line in the above graph depicts the permit condition of 115l/s of PFF before the asset is permitted to discharge.

$3,347,100 \times 25\text{l/s} = 83,677,500$ litres of settled sewage which has been discharged which should have been passed forward to full treatment.

In summary during the period June 2021 to April 2023, there was a total of 3719 readings over limit, this equates to $3719 \times 15\text{min} \times 60\text{s} = 3,347,100 \times 25\text{l/s} = 83,677,500$ litres of settled sewage which has been discharged from the asset in breach of permit.

This pump station is required by permit to comply with Condition 4 of passing at least 115l/s of PFF.
