### 4. Details of our assessment

This was a routine unannounced compliance visit carried out by Malcolm Dines and Holly Dyke. The weather was overcast and damp with a storm due to arrive later in the day. On arrival officers met with Trevor Tame the site manager, but carried out the site inspection

unaccompanied.

The two bays were both in use with one full, although you ensure that "full" is only about 3/4 of the capacity of the bay to ensure that the drains don't get blocked. there was no evidence of material having spilled over the wall of the bay which shows that the loading of the bays is carried out carefully. The roadsweepings are only stored at the site and no treatment takes place with the current procedure being that the roadsweepings are transported to a permitted site in South Wales.

Technical Competence was not assessed at the site. Currently we have three people listed as being Technically Competent Managers: Martin O'Shea; Trevor Tame and Colette Evans. Our current information shows that all of their Continuing Competency has expired. Please provide details of the person(s) providing Technical Competence cover for this site and their Continuing Competency certificate(s) or if they are new, their Qualification as well. Please provide this information by **1st November 2023**
