3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

Routine sampling from 27/9/23 generated an exceedance of Suspended Solids, with the maximum Permitted being 60 mg/l and the sample at 116 mg/l, which was confirmed by repeat analysis. This is a breach of Permit Condition 8.

In addition to this, NRW has received multiple reports from members of the public regarding the condition of the outfall and potential impact on the Afon Tarrell SSSI and SAC. The investigations from these reports have identified an unknown substance that has

been settling on the outfall steps and immediately downstream. This sediment has been traced back to coming from the Beacon Foods discharge into the surface water drain - please see attached Photo.

Please send me the last 12 months data for the site discharge - including the weekly sampling reports, a copy of the daily informal phosphate monitoring, flow monitoring and any other data currently available. Please also send across a list of waste exports, including volume and their final destinations.

You need to bring the discharge back into compliance, in order to facilitate this NRW is considering issuing an Improvement Notice under the Environmental Permitting (England and Wales) Regulations 2016.

I will revisit the site within the next two weeks to take another sample for analysis to confirm compliance.
