4. Details of our assessment

This report details the site visit made on the 29 September 2023 to S & R Whistance Ltd, permit reference number EPR-CB3094CJ.

Officers Carla CURTIS, Jodie BASKERVILLE and Mark O'Gorman attended site at 11:00 for an unannounced routine site inspection. The weather was sunny and mild.

GENERAL OBSERVATIONS

We were met on site by Michael WHISTANCE (Site Manager) who informed us that the site was currently non-operational having previously been used as a storage and recycling hub of waste inert materials.

Infrastructure and drainage of the site was inspected, the surface was in good condition throughout the site.

The Technically Competent Manager (TCM) for the site is Adam WILSON

WASTE RETURN SUBMISSIONS

According to NRW records, S & R Whistance Ltd have not submitted any waste return data since the granting of their permit in March 21.
