#### 4. Details of our assessment

reports of poor effluent from treatment plant after routine monitoring by NRW, cause identified as hydraulic overloading from water ingress in the private sewer system feeding the plant. Further discussion with permit holder (Powys county council) suggest ongoing investigation into surface water ingress is underway, at the time of writing Compliance form no further information has been offered to NRW.
