3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

Following a reported pollution incident to a sub tributary of the Cartlett Brook an officer attended the scene on the 10/10/23 and identified the source as being an outfall pipe from Puffin Produce which was seen to be discharging heavily soil laden water in to the watercourse which resulted in significant discolouration. The site manager at Puffin's Produce was then notified of the issue and advised to ensure that the pollution ceased as soon as was practically possible. Furthermore, the team was notified by the site manager that the cause of the issue was a mechanical fault during the cleaning process for the potatoes arriving that day. The decision was made to issue the business with a warning letter. A visit has now been arranged to allow for the Pembrokeshire Environment Team to be given a tour of the factory floor to help understand the operations of the business and identify means of avoiding a repeat occurrence in future.
