4. Details of our assessment

Natural Resources Wales officer Shaun Rees met with Will Lea, Steve Carlyle and Ben Hartley of Country Fresh Pullets/Lloyds animal feeds to carry out an audit for the site on the 2nd October 2023. Thank you for your time during the visit.

This audit was being carried out due to a notification received by NRW that the site was operating above the permitted number of birds.

Permitted activities

Operators must ensure that the site operates to the permitted numbers as stated within their permit at all times and failure to do so will result in a non-compliance and possible enforcement action against the site

- *Extra birds removed from site, no further action required.*

Notifications

The site must notify NRW of any permit breaches within 24 hours as stated within their permit. -

- *Notification received by NRW on the 30th August 2023, 19 days after delivery of the birds to the site. No further action possible.*

General management

Please put in place a system in which will enable the site to clarify exact number of birds to be delivered to the site to ensure the site operates within its permitted numbers at all times.

- *Please ensure this is in place by the 14th November 2023 and photographic evidence provided.*

Legal status of this report
