4. Details of our assessment

This was a Quality Assurance inspection carried out by Phil Canning NSF. There were no NRW officers present during the inspection.

The inspecting officer identified under AR 3.3 of the inspection form that the poultry manure which is used on the farm and not exported had not been analysed for last 6 months. This is not a requirement of the permit under Operating Techniques IRC2 which does not stipulate the requirement to analyse the manure, however under The Water Resources (Control of Agricultural Pollution) (Wales) Regulations 2021 there is a requirement to ensure manure is analysed and in order to comply with these new Regulations it should be analysed.

There were no breaches of the permit identified.
