4. Details of our assessment

Assessment type: Routine site inspection.

Weather: Overcast heavy showers.

Since the previous site inspection, the package treatment plant has been installed and is operational. We note the final effluent is not yet being discharged via outlet 1, located at national grid reference SO 5021405621.

The sewage treatment plant remains connected to the green tank which has been used to store treated effluent before it is removed by tanker to an authorised treatment facility.

Condition 3, Schedule 1, states, surface water and ground water must not enter the treatment system, and Schedule 3 sets out the maximum daily discharge as 9 m³/.

Before you reconnect the sewage treatment plant to the sewer network which discharges at outlet 1, shown in the site plan in Schedule 7. Please provide confirmation in writing to Natural Resources Wales the problem with ground water and surface water ingress into the system has been rectified. Secondly, please advise when you intend to start discharging the final effluent from outlet 1 to the receiving water. As set out in condition 4.3.1 Natural Resources Wales shall be notified without delay following the detection of:

- (a) any malfunction, breakdown or failure of equipment or techniques, accident, or emission of a substance not controlled by an emission limit which has caused, is causing or may cause significant pollution;
- (b) the breach of a limit specified in the permit; or
- (c) any significant adverse environmental effects.
