4. Details of our assessment

General Management Permit condition 1.1

Paperwork was kept up to date and reviewed on an annual basis. Correct documentation was displayed upon entry to site including emergency contact details. EMS and permits were easily accessible in the office to staff.

All paperwork was kept up to date and reviewed. Including accident management plan, inspection and maintenance plan, policy statements, complaints procedures and site closure plan. Staff training was up to date and certificates were shown.

General Management Permit condition 1.3

Raw material entering and leaving the site was in the form of straw pellet bedding.

Permit activities - Permit conditions 2.1

There were no changes to the permit conditions seen, the activity of the site remains the same .

The site remains compliant with the number of birds on site totalling 97,700 on the day of inspection, which is within the agreed limits.

Operating Techniques - Permit conditions 2.3

The site correctly records and documents all manure, fallen stock and plastic waste that leaves the farm. Bedding is brought into the site via bulk carriers keeping plastic waste to a minimum. Fallen stock is retrieved by Cymru Lan and plastic waste is taken in bulk bag to Derwydd.

The flock are on a relevant feeding strategies ensuring excess P and N are not fed and are reduced accordingly

Permit Conditions 3.2

The site is well maintained, clean and tidy all building are in good condition. Clear biosecurity practices with footbaths provided that are changed regularly. Carcasses stored correctly and disposed of correctly.
