We have reviewed your responses received 25.07.2023 and 27.10.2023 to the Schedule 5 Notice issued to Maelor Foods Ltd on 24.05.2023. Your responses have not satisfactorily addressed all of the information requested in the schedule 5 Notice. You have not provided a revised Noise Impact Assessment in line with published guidance.

We are therefore reissuing the Schedule 5 Notice to you. We have included additional comments within the Schedule 5 Notice to assist you with providing the required information. Annotations are in blue.

The agreed extended deadline for the Notice has now passed. We are therefore extending the deadline one final time, for you to provide the outstanding information. The new deadline for you to provide the outstanding information is 13.12.2023.

In addition I also enclose a second Schedule 5 Notice asking you to send us more information to support your application. We need this information so that we may continue to process your application. The notice specifies what you need to send and when you must send it by.
